## February 11th, 2019

MINUTES FEBRUARY 11th, 2019 WORK SESSION START: 7:30 PM

PRESENT: MAYOR NICOL, COUNCILMEN GARRUZZO, GIANFORTE & NOLAN, ATTORNEY MONTENEGRO & ADMINISTRATOR NOLAN.

ABSENT: COUNCILMEN GORHAM, SHAAK AND VISGELIA

Mayor Nicol announced that any member of the public wishing to audio or video record a Council Meeting must give notice to the Borough Clerk prior to the meeting being recorded.

Mayor Nicol opened the Work Session in compliance with the Open Public Meetings Act and recognized the Administrator who had no report, but he asked to add a resolution to the consent agenda to ensure municipal compliance with the new NJDEP water quality guidelines.

Councilman Gianforte added that the quality of our drinking water was a vital concern he believed that it was a positive step to undertake the Assets Management Plan.

There being no questions from Council or the public, the work session was adjourned at 7:32 p.m. on a motion by Councilman Gianforte seconded by Councilman Nolan.

Mayor Nicol then announced that the time for a hearing and further consideration of "AN ORDINANCE TO AMEND CHAPTER FOURTEEN OF THE CODE OF THE BOROUGH OF BRIELLE ENTITLED "FIRE PREVENTION &

## SAFETY".

The hearing was opened on a motion by Councilman Gianforte seconded by Councilman Nolan.

The Administrator explained that the ordinance simply eliminated all references to the Brielle Fire Bureau to bring the ordinance into compliance with the new Inter-Local Agreement with Sea Girt.

The hearing was closed on a motion by Councilman Gianforte seconded by Councilman Nolan.

Councilman Garruzzo seconded by Councilman Nolan, introduced Resolution 19-23 for passage on final reading of the foregoing ordinance. Vote: Councilmen Garruzzo, Gianforte & Nolan; all aye. No nays. Passed.

Councilman Garruzzo seconded by Councilman Nolan introduced Resolution 19-24 to authorize publication of passage and adoption in the Coast Star according to law. Vote: Councilmen Garruzzo, Gianforte & Nolan; all aye. No nays. Passed.

The Mayor then called for committee reports and recognized Councilman Gianforte who had no report.

Councilman Nolan advised the public that the Library would conduct a One Hundred Days Until the Centennial observance on February 20th. Wine and cheese would be served.

Councilman Nolan also noted that plans were underway to upgrade the path between Borrie and Woodland Avenue.

Councilman Garruzzo having no report, the meeting was open to the public. There being no public comment, the meeting was closed on a motion by Councilman Gianforte seconded by Councilman Nolan at 7:36pm.

NOW, THEREFORE BE IT RESOLVED, that the Governing Body of the Borough of Brielle hereby declares that the affirmative vote of a majority of a quorum is needed to pass a borough resolution, with the mayor only voting in the case of a tie.
