The construction of new kayak racks will be continuing over the next three weekends.

New Jersey Natural Gas has been repairing trenches along Higgins Avenue and hoped to complete the job before Memorial Day.

Turning to the Library cited the Medicare Seminar on May 24th, Paint & Sip on May 26th and Author Steve Berry on June 7th.

Councilman Garruzzo had no report, but he praised the Fire Company's "Wet Down" on Saturday noting that it was well attended, and the "kids" had a great time.

Councilmen Shaak, Gorham & Visceglia having no reports, the Municipal Clerk advised that no public comment had been received from by either e-mail or regular mail Brielle prior to the meeting.

Mayor Nicol then cited his attendance at events at the Brielle Sports Club and the Wet Down on Saturday. At both events he was approached by residents who praised the beauty of the Borough and how well kept it was. Mayor Nicol tipped his hat to the D.P.W. for a job well done.

Urging the Swift Passage of S-330 which restores Energy Tax Receipts

WHEREAS, taxes on gas and electric utilities were originally collected by the host municipalities to be used for local purposes and to compensate the public for the use of their rights of way; and

WHEREAS, when the State made itself the collection agent for these taxes, it promised to dedicate the proceeds to municipal property tax relief; since, just as municipalities collect property taxes for the benefit of school districts, counties, and other entities, the State is supposed to collect Energy Taxes for the benefit of municipal governments; and

WHEREAS, for years, though, State budget makers have diverted funding from Energy Taxes to fund State programs; and instead of being spent on local programs and services and used to offset property taxes, the money has been spent as successive Legislatures and Administrations have seen fit; and

WHEREAS, the diversion of dedicated energy tax receipts to the State's General Fund further jeopardizes this critical property tax relief funding in future years; and

WHEREAS, by reducing Consolidated Municipal Property Tax Relief Act (CMPTRA), which is also comprised of revenues that should be returned to municipalities, State Budget makers have been able to continue collecting Energy Taxes, while keeping additional revenue that should have been returned to provide property tax relief; and

WHEREAS, the cumulative impact of years of underfunding has left many municipalities with serious needs and burdensome property taxes; and

WHEREAS, local elected officials are in the best position to decide the best use of these resources, which were always intended to fund local programs and services; and

WHEREAS, Senator Singleton and Senate President Scutari have introduced legislation (S-330) that will restore, over a five-year period, Energy Tax Receipts to municipalities;

NOW, THEREFORE, BE IT RESOLVED, that the governing body of the borough of Brielle in the County of Monmouth urges the Legislature to swiftly pass this legislation and Governor Murphy sign the legislation prior to passage of the FY2023 State budget; and

BE IT FURTHER RESOLVED that a copy of this Resolution is forwarded to Senator Singer, Assemblymen Kean and Thompson, Senate President Scutari, Assembly Speaker Coughlin, Governor Murphy, and the League of Municipalities.
