MINUTES August 12th, 2019 WORK SESSION START: 7:30 PM

PRESENT: MAYOR NICOL, COUNCILMEN GARRUZZO, GIANFOTE, GORHAM, NOLAN, SHAAK & VISCEGLIA, ATTORNEY MONTENEGRO & ADMINISTRATOR NOLAN.

ABSENT: NONE

Mayor Nicol announced that any member of the public wishing to audio or video record a Council Meeting must give notice to the Borough Clerk prior to the meeting being recorded.

Mayor Nicol then opened the Work Session in compliance with the Open Public Meetings Act and recognized the Administrator who had no report but asked to add two resolutions to the consent agenda. The first would authorize the preparation of plans and specifications and construction administration for the ADA improvements to Borough Hall. The second is a Chapter 159 Resolution to permit the use of grant money.

The Chair then recognized Councilman Garruzzo who announced the promotion of Special Officer Dante Brown to the rank of Probationary Patrolman. Councilman Garruzzo advised that Dante joined the Department as a Class II Officer on July 23rd, 2018. Prior to joining the Brielle Police Department, Officer Brown had been employed by the Asbury Park Police Department for a period of five years as a Class I and a Class II Officer.

Officer Brown was raised in Neptune Township by his parents, Cynthia and Winston Brown. He has a sister Monae. Officer Brown graduated from the Monmouth County Police Department as a Class II Special Officer on May 23rd, 2017. Officer Brown also holds an Associate Degree in Criminal Justice from Brookdale Community College.

Retired Chief Michael Palmer being present he noted how, upon the recommendation of Eugene Delo of the Asbury Park Police Department he interviewed Dante for the position of Class II Special, He pointed out that Brielle is a demanding place to work and expectations run high, but Dante rose to the occasion. Chief Palmer did remind Patrolman Brown to always keep his smile.

Chief Olsen welcomed Dante to the Brielle family and echoed Chief Palmer as to the demand the department placed on its officers. We demand more and expect more. Officers must show professionalism, pride and integrity and Dante exhibited those virtues. The Chief noted that Brielle was the best department in the state and with Dante's promotion; it just got better.

Chief Olsen thanked the Mayor & Council for their support of the promotion, and he welcomed Dante's Parents to the Brielle Family.

Mayor Nicol offered that Dante's parents had done a great job in raising him and noted that he had been a resident of Neptune Township for twenty-three years prior to moving to Brielle.

Patrolman Brown was recognized, and he thanked the Mayor & Council, Chief Olsen for their support and in providing him with this opportunity.

Councilman Shaak then referenced the events of July 1st when the Brielle First Aid Squad, where he serves as Captain, received a call. At first it was received as a seizure, but a second call advised that CPR was in progress. Upon arrival, the Squad found that Michael Franzoni was engaged in CPR.

Mr. Franzoni had heard a commotion and responded, the man in distress was a stranger, but without hesitation he remembered his CPR training and sprang into action, calling 911, and then commencing CPR. Thanks to his efforts the patient revived and was taken to the hospital where he unfortunately passed on, but Michael's efforts had given him a chance.

Councilman Shaak then read a Proclamation (see insertion) Family and friends, retired Sergeant Murphy from

Manasquan and Ms. Zantucci, join Michael for a commemorative photograph.

There being no questions from Council or the public, the work session was adjourned at 7:50 p.m. on a motion by Councilman Gianforte seconded by Councilman Nolan.

The Mayor then called for committee reports and recognized Councilman Gianforte who had no report but cited the elevation of two Eagle Scouts Ian Walsh & Paddy Brennan at the Fire House on Sunday.

Councilman Nolan noted that the Library will be conducting a painting contest to determine decorations for the four panels on the wall running along the right front side of the building. The contest is open to all students, individual or team, with a September 29th deadline for draft drawings. Paintings must be completed by October 31st.

Councilman Nolan also thanked Mayor & Council for authorizing the Island Clean-up by the Scouts.

Councilman Garruzzo advised that National Night Out had been a success with increased participation. He thanked Councilman Visceglia for his work "behind the grill". The Marine Unit continues to be busy. The

department also ran a vehicle inspection check point, in partnership with the State Motor Vehicle Commission. Of forty vehicles inspected to ensure compliance by removing dangerous vehicles from the road and promoting safe driving practices, eight failed and fourteen summonses were issued. There was also one arrest for possession of a controlled dangerous substance and possession of drug paraphernalia.

On August 21st another pedestrian safety operation will be held on State Highway #71. Pedestrians will also be spoken to ensure that they are also following the law and crossing properly. Pedestrians should always use the designated marked crosswalks and never cross in the middle of an intersection.

The "Drive Sober or Get Pulled Over" campaign will be conducted from August 8th to September 2nd. The event highlights an effort that is in effect year around.

Councilman Shaak advised that the Mamie Moon Memorial Walk connecting Borrie and Woodland Avenues had been completed and would be a boon for area residents. Councilman Shaak also noted that the Union Lane project was on schedule and would be completed before the beginning of the school year.

Councilman Gorham & Visceglia having no reports the meeting was opened for public comment.

Charlotte Madison, 206 Homestead Road, cited an on-going problem with the dumpster at Hoffman's Landing. Despite her complaints to Code Enforcement and the Municipal Court, she had been told by the Judge, via letter, that there was no probable cause for action, despite her photographs and outline of the problem of the dumpster door being continually left open, contrary Page 64

to Borough Ordinance, and obvious health hazard caused by spilled trash. She had been referred to Zoning. She asked for direction.

The matter was referred to Attorney Montenegro who would contact the municipal court and attempt to provide a course of action.

There being no further comments, the meeting was closed on a motion by Councilman Gianforte, seconded by Councilman Garruzzo at 7:56pm.

A RESOLUTION URGING LEGISLATORS TO TAKE ACTION TO OPPOSE AND SEEK CHANGES TO THE REAUTHORIZATION OF THE NATIONAL FLOOD INSURANCE PROGRAM (NFIP)

Whereas, floods are one of the most common and most destructive natural disasters in the United States, and

Whereas, the National Flood Insurance Act authorizes a National Flood Insurance program (NFIP), and Whereas, the NFIP is a program created by Congress to mitigate future flood losses across the United States and to further provide access to affordable flood insurance protection for property owners, and Whereas, the NFIP is designed to provide an insurance alternative to disaster assistance to meet the increasing costs of repairing damage to buildings and their contents caused by floods, and Whereas, New Jersey is third among states in total value of claims paid and fourth in the number of NFIP policies enforced, and

Whereas, five hundred and fifty-two communities in New Jersey participate in NFIP, and

Whereas, NFIP maintains a significant role in providing financial protection against flood events to New Jersey property owners, and

Whereas, the NFIP is set to expire on September 30, 2019, and

Whereas, on June 12th the House Financial Services Committee unanimously passed legislation to reauthorize and reform the NFIP, known as H.R. 3167, and

Whereas, the proposed reauthorization provides for the following unacceptable terms, the increase of rates to primarily homeowners up to 18% annually until they reach their actuary rate (meaning that every four years, premiums may double), the increase of rates to secondary homeowners up to 25% annually, until they reach their actuary rate (every three years premiums may double), the increase to risk/premiums to communities that have higher construction/replacement costs, the implementation of risk rating 2.0 mapping which results in higher premiums the closer you live to the water, and an increase to the cost of compliance limits that is still insufficient to meet actual numbers.

NOW THEREFORE BE IT RESOLVED, that the Governing Body of the Borough of Brielle finds the current rate schedule to be unacceptable and a detriment to the public interests and it urges its legislators to take all necessary action to ensure that the reauthorization of NFIP provide affordable rates to property owners. BE IT FURTHER RESOLVED, that a certified copy of this Resolution be forwarded to the Borough's Congressional Delegation.
