MINUTES: June 13<sup>th</sup>, 2022 START: 6:00 P.M.

PRESENT: MAYOR NICOL, COUNCILMEN GARRUZZO, GORHAM, NOLAN, SHAAK & VISCEGLIA, ATTORNEY MONTENEGRO & ADMINISTRATOR NOLAN.

ABSENT: Councilman Gianforte

Mayor Nicol announced that this meeting was being held virtually in compliance with Executive Order No. 103 and was being recorded.

There being no need for a work session, Mayor Nicol then read the compliance statement and the Regular Council Meeting was opened, after a pledge of allegiance to our flag. Mayor Nicol asked for a roll call.

Mayor Nicol then asked for a motion to approve the Minutes of the May 23<sup>rd</sup>, 2022 meeting. A motion was made by Councilman Nolan seconded by Councilman Visceglia, all ayes, no nays.

Prior to the consent agenda resolution, the Administrator requested permission to add three proforma resolutions to the consent agenda. The first two resolutions confirmed the sale of municipal bonds to the New Jersey Infrastructure Bank and established the repayment schedules. The third resolution authorized an emergency to replace the A/C condenser at the Curtis House.

Councilman Garruzzo seconded by Councilman Visceglia, introduced Resolution 22-54 for passage of the Consent Agenda.

Councilman Visceglia seconded by Councilman Gorham introduced Resolution 22-63 For Payment of Bills Be It Resolved that the following bills be paid, and that the Mayor or President of Council be authorized to draw orders on the Chief Finance Officer for payment of the bills of June 13<sup>th</sup>, 2022, as reviewed by the Finance Committee and as listed on the Resolution and the Computer Bill List amended thereto. Vote: Councilmen Garruzzo, Gorham, Nolan, Shaak & Visceglia; all ayes. No nays. Passed.

The Mayor then called for committee reports and recognized Councilman Nolan who advised that the Library would celebrate its One Hundred Anniversary sometime in July. Councilman Nolan also cited the Book Club meeting tomorrow, Kids Magic Show on June  $21^{st}$  @ 3:30pm, Author Joanne Cherefko on June  $23^{rd}$  @ 4:30pm, followed by author Mary Alice Monroe on the  $25^{th}$ . There would also be an SSI Workshop on June  $27^{th}$  and a seminar on Medicare on June  $29^{th}$ . In addition, a Farmer's Market/Strawberry festival will be held sometime soon.

Turning to recreation, the pickle board court was in operation, the kayak rack construction was nearing completion, 112 children had already signed up for the summer recreation program, and the North South Competition had raised \$20,000 to benefit the Anderson Family.

Councilman Nolan then reported as liaison to the Environmental Commission, that the Commission wished to remind residents and anyone who used Nienstedt Island, that the island was an environmentally sensitive area. The Commission was concerned about the threat of erosion exacerbated by boaters beaching their craft as well as visitors letting their dogs run free as they posed a direct threat to nesting birds and other wildlife. The island was home to hermit crabs, numerous waterfowl and recently contained an eagles nest. Otters were seen in the adjacent waters.

All these creatures were at risk when visitors ignored the rules and regulations codified by ordinance. These rules would be strictly enforced as it is essential that this vital resource be preserved for future generations.

Councilman Garruzzo cited the resignation of Sergeant Stahl and praised his service during his ten years with the Borough, he wished him the best in his future endeavors.

Councilman Garruzzo welcomed Kevin Luxich to the force and noted that he had been a police officer in Plumsted Borough; he would be a welcomed addition to a police force that Chief Olsen had crafted into one of the finest departments in the state.

Councilman Shaak, Gorham, and Visceglia having no reports, the time had arrived for an Executive Session.

There being no further public comment, Councilman Nolan seconded by Councilman Shaak introduced Resolution 22-64 to enable an Executive Session.

Whereas, the Open Public Meetings Act permits the exclusion of the Public from a meeting in certain circumstances; and Whereas, the Borough Council of the Borough of Brielle is of the opinion that such circumstances currently exist. Now Therefore Be It Resolved, by the Borough Council of the Borough of Brielle, County of Monmouth, State of New Jersey, on September 14th, 2015, as follows:

- 1. The Public shall be excluded from discussion of and action upon the hereinafter specified subject matters.
- 2. The general nature of the subject matter to be discussed is as follows: "Pending Litigation".
- 3. It is anticipated at this time that the above stated subject matters will be made public when the need for confidentiality no longer exists.

Councilman Shaak then left the meeting due to a possible conflict regarding the topic to be discussed.

The Executive Session began at 6:11 p.m. and ended at 6:47p.m. The session was adjourned on a motion by Councilman Visceglia seconded by Councilman Gorham.

Attorney Montenegro stated that no action was being taken and that the matter would be made public when the need for confidentiality no longer existed.

The meeting was then opened to the public. There being no public comment, the meeting was adjourned at 6:48 p.m. on a motion by Councilman Visceglia seconded by Councilman Gorham.
