Mayor Nicol then announced that the time had arrived for the introduction and passage on first reading of "AN ORDINANCE TO AMEND AND SUPPLEMENT SECTION 21-9, REGULATIONS APPLYING TO ALL ZONES, CHAPTER XXI ZONING, IN THE BOROUGH OF BRIELLE"

Councilman Garruzzo seconded by Councilman Nolan, introduced Resolution 18-27 for passage on introduction and first reading of the foregoing ordinance. Vote: Councilmen Garruzzo, Gianforte, Gorham, Nolan, Shaak & Visceglia; all aye. No nays. Passed

Councilman Gianforte seconded by Councilman Nolan, introduced Resolution 18-28 to authorize publication in the Coast Star for a hearing to be held on March 12th, 2018 @ 7:30 pm, at Borough Hall. Vote: Councilmen Garruzzo, Gianforte, Gorham, Nolan, Shaak & Visceglia; all aye. No nays. Passed

Councilmen Gianforte, Nolan, Visceglia and Gorham having no reports, Councilman Shaak cited the receipt of a \$315,000.00 grant from NJDOT to repave Union Lane from Highway 71 to Old Bridge Road.

Councilman Garruzzo advised that the Police have been working with the Elementary School for many years implementing security measures. The department and school officials have a continuous line of communication for enforcing and increasing security measures. Police Officers have always been present at both arrival and departure times and have conducted "walk-throughs" at the school at various times of day. A camera system that permits Officers to view the school from both headquarters and in patrol vehicles has been installed. In addition a WAVE System was installed several years ago. This system sends a signal to officers wherever they are so their response time is greatly enhanced. The Police have also participated in school lockdown drills.

The Police Department has increased its presence at the school, but some security measures cannot be discussed in public as that would impair their effectiveness.

There being no public comment, the public portion was adjourned on a motion by Councilman Shaak seconded by Councilman Gorham.

The meeting was then adjourned at 7:42pm on a motion by Councilman Gianforte seconded by Councilman Nolan.
