MINUTES September 24th, 2018 WORK SESSION START: 7:30 PM

Mayor Nicol announced that any member of the public wishing to audio or video record a Council Meeting must give notice to the Borough Clerk prior to the meeting being recorded.

Mayor Nicol convened the work session in compliance with the Open Public Meetings Act and recognized the Administrator who advised that he had nothing to report, but he asked permission to add a resolution to the consent agenda to cover an emergency repair to a water main on Leslie Avenue.

Councilman Shaak seconded by Councilman Gorham introduced Resolution 18-114 for Payment of Bills. Be It Resolved, that the following bills be paid, and that the Mayor or President of Council be authorized to draw orders on the Chief Finance Officer for payment of the bills of September 24th, 2018, as reviewed by the Finance Committee and as listed on the Resolution and the Computer Bill List amended thereto. Vote: Councilmen Garruzzo, Gianforte, Gorham, Nolan & Shaak; all aye, No nays. Passed (Note: Councilman Shaak was appointed to Finance for purposes of this meeting.)

Mayor Nicol then called for committee reports and recognized Councilman Gianforte who advised that he had nothing to report.

Councilman Nolan cited the success of the Library's Visions Program and receipt of new "white boards" and lap-tops for use within the Library. Councilman Nolan then reminded the public that the annual Fall Festival would be October 14th. He also advised that surveillance cameras were being activated in the park through a joint effort of the Library, Recreation and the Police Department.

Councilman Garruzzo advised the public that, on September 16th at 3:30am, Patrolman Aridas and Cusack contacted a suspicious vehicle on South Tamarack Drive. The car contained three Page 76

individuals who were evasive throughout the contact. The Police believe that the subjects were in Brielle with the intent of either committing a criminal action or conducting surveillance for a future criminal act. Subsequent to the stop, a criminal intelligence report advised that the subjects had a known history of vehicle thefts.

The Police urge residents to remain vigilant and to report any suspicious activity or individuals to the Brielle Police. Additionally, residents should secure their motor vehicles and remove personnel items and their associated keys or fobs. The latter should always be kept inside the home. Councilman Garruzzo added that residents should keep their doors and windows locked, as well as garage doors.

Councilman Shaak informed the public that the week of October 1st would be "bulk-pick-up" on the residents' regular day of collection.

Councilman Gorham having no report the meeting was open to the public. There being no public comment, the meeting was adjourned at 7:39 pm on a motion by Councilman Gianforte seconded by Councilman Nolan.

Borough of Brielle Model Civil Rights Resolution

A RESOLUTION TO AFFIRM THE BOROUGH OF BRIELLE'S CIVIL RIGHTS POLICY WITH RESPECT TO ALL OFFICIALS, APPOINTEES, EMPLOYEES, PROSPECTIVE EMPLOYEES, VOLUNTERS, INDEPENDENT CONTRACTORS, AND MEMBERS OF THE PUBLIC THAT COME INTO CONTACT WITH MUNICIPAL EMPLOYEES, OFFICIALS AND VOLUNTEERS

WHEREAS, it is the policy of the Borough of Brielle to treat the public, employees, prospective employees, appointees, volunteers and contractors in a manner consistent with all applicable civil rights laws and regulations including, but not limited to the Federal Civil Rights Act of 1964 as subsequently amended, the New Jersey Law against Discrimination, the Americans with Disabilities Act and the Conscientious Employee Protection Act, and

WHEREAS, the governing body of the Borough of Brielle has determined that certain procedures need to be established to accomplish this policy

NOW, THEREFORE BE IT ADOPTED by the Mayor and Council that:

Section 1: No official, employee, appointee or volunteer of the Borough by whatever title known, or any entity that is in any way a part of the Borough shall engage, either directly or indirectly in any act including the failure to act that constitutes discrimination, harassment or a violation of any person's constitutional rights while such official, employee, appointee volunteer, or entity is engaged in or acting on behalf of the Borough's business or using the facilities or property of the Borough.

Section 2: The prohibitions and requirements of this resolution shall extend to any person or entity, including but not limited to any volunteer organization or inter-local organization, whether structured as a governmental entity or a private entity, that receives authorization or support in any way from the Borough to provide services that otherwise could be performed by the Borough.

Section 3: Discrimination, harassment and civil rights shall be defined for purposes of this resolution using the latest definitions contained in the applicable Federal and State laws concerning discrimination, harassment and civil rights.

Section 4: The Administrator shall establish written procedures for any person to report alleged discrimination, harassment and violations of civil rights prohibited by this resolution. Such procedures shall include alternate ways to report a complaint so that the person making the complaint need not communicate with the alleged violator in the event the alleged violator would be the normal contact for such complaints. Section 5: No person shall retaliate against any person who reports any alleged discrimination, harassment or violation of civil rights, provided however, that any person who reports alleged violations in bad faith shall be subject to appropriate discipline.

Section 6: The Administrator shall establish written procedures that require all officials, employees, appointees and volunteers of the Borough as well as all other entities subject to this resolution to periodically complete training concerning their duties, responsibilities and rights pursuant to this resolution.

Section 7: The Administrator shall establish a system to monitor compliance and shall report at least annually to the governing body the results of the monitoring.

Section 8: At least annually, the Administrator shall cause a summary of this resolution and the procedures established pursuant to this resolution to be communicated within the Borough. This communication shall include a statement from the governing body expressing its unequivocal commitment to enforce this resolution. This summary shall also be posted on the Borough's web site.

Section 9: This resolution shall take effect immediately.

Section 10: A copy of this resolution shall be published in the official newspaper of the Borough in order for the public to be made aware of this policy and the Borough's commitment to the implementation and enforcement of this policy.
