MINUTES APRIL 24th, 2017 WORK SESSION START: 7:30 PM

PRESENT: MAYOR NICOL, COUNCILMEN GARRUZZO, GIANFORTE, NOLAN & SHAAK, ATTORNEY MONTENEGRO & ADMINISTRATOR NOLAN.

ABSENT: COUNCILMAN GORHAM and VISCEGLIA

Mayor Nicol announced that any member of the public wishing to audio or video record a Council Meeting must give notice to the Borough Clerk prior to the meeting being recorded.

Mayor Nicol convened the work session in compliance with the Open Public Meetings Act and recognized the Administrator, who had no report.

Mayor Nicol then recognized Eagle Scout candidate Louis Monetti, 651 Oceanview Road who presented his project which was three-fold. First, he wished permission to support law enforcement by painting a blue line, between the existing yellow lines, for a distance of approximately 1500 feet along Union Lane from the intersection of Highway #71 to the Curtis House. The project would consume 5 gallons of paint @ \$35.00 per gallon. Chief Palmer had offered to provide reflective vests and traffic control on May 7th, the projected date for the project. The next phase would support the families of police officers who were deceased by purchasing and displaying ribbons during National Police Force Week, May 14th through 20th. Mr. Monetti would distribute flyers and forms with information on how to obtain the ribbons either via the web or by contacting him directly.

Finally, Mr. Monetti wished to place a plaque at Curtis House to explain the purpose of the blue line and its relationship to law enforcement. Councilman Shaak thought it was an excellent project and noted that when Mr. Monetti had first contacted him in January he had referred him to Chief Palmer.

Councilman Nolan concurred, but pointed out that Mr. Monetti should check the State Right-of-way for Route #71 as that area could not be painted without state permission.

Mayor Nicol asked about pending legislation regarding the blue line issue. Mr. Monetti advised that it was still pending, but Chief Palmer believed that the concerns cited in the bill were not applicable to local roadways. Attorney Montenegro interjected that there was an issue with line of sight and visibility, but it was confined to state highways and roads.

Council endorsed the project.

There being no questions from Council or from the public, there was no further discussion and the work session was adjourned at 7:40 pm on a motion by Councilman Shaak seconded by Councilman Gianforte.

Resolution of the Borough of Brielle

Whereas, the State of New Jersey Bureau of Fire Safety requires that a municipality provide for an alternate to provide for the services of Fire Official in the event that the individual appointed to fulfill these duties, by the municipality, should be unavailable due to illness, vacation, bereavement, or any other reason that would prevent said individual from providing these essential services, and

Whereas, the Borough of Brielle and the Borough of Sea Girt have agreed that it is in the best interest of both municipalities to provide such reciprocal services for the position of Fire Official, and

Whereas, both municipalities agreed that these services will be provided at no charge on an "as needed" basis with the exception that, in the event the absence of either municipalities Fire Official extends beyond a period of thirty (30) days the municipality providing the reciprocal service shall be entitled to compensation at the daily rate being paid to the Fire Official who is providing the service.
