MINUTES APRIL 22nd, 2019 WORK SESSION START: 7:30 PM

PRESENT: MAYOR NICOL, COUNCILMEN GARRUZZO, GIANFORTE, NOLAN, SHAAK & VISGELIA, ATTORNEY MONTENEGRO & ADMINISTRATOR NOLAN.

ABSENT: COUNCILMAN GORHAM

Mayor Nicol announced that any member of the public wishing to audio or video record a Council Meeting must give notice to the Borough Clerk prior to the meeting being recorded.

Mayor Nicol then opened the Work Session in compliance with the Open Public Meetings Act and recognized the Administrator who had no report.

Councilman Garruzzo was then recognized. As Police Commissioner & Chairman of Public Safety, Councilman Garruzzo noted that it was an honor and a pleasure to announce the promotion of patrolman Kevin Williams to Sergeant. Mr. Williams joined Brielle as a Class II Special Officer in May of 2008, having already served in that position for two years in Point Pleasant Beach. In December 2010, he became a Patrolman.

During his time with the department, Mr. Williams has served as a firearms instructor, patrol rifle instructor, a Field Training Officer and an OC Instructor. As a Patrolman, Mr. Williams has been proactive and is a six-time recipient of the Mothers Against Drunk Driving Distinguished Service Award and he has also earned the New Jersey DWI "Top Gun" Award.

Our newest Sergeant has also served as a member of the Southern Monmouth County Active Shooter Partnership where he is an instructor responsible for training officers from all South Monmouth law enforcement agencies in Active Shooter Response. He is also an instructor in Emergency Vehicle Operations and has trained recruits at the Monmouth County Police Academy in the safe operation of patrol vehicles.

Sergeant Williams is a graduate of Ocean County College where he earned a degree in criminal Justice. He is also a graduate of the New Jersey Police Supervision & Leadership Program. Sergeant Williams resides in Point Pleasant with his wife Marie and their two sons, Brayden & Logan.

In the absence of Chief Olsen who was unable to attend, Lieutenant Mechler praised Sergeant Williams as an asset to the department, whose knowledge and dedication had benefited everyone, especially the younger officers who he was always willing to help. Lieutenant Mechler congratulated Sergeant Williams on his appointment and wished him the best of luck.

Sergeant Williams thanked Chief Olsen and his predecessor Chief Palmer for their support throughout his career along with Mayor & Council.
