Mayor Nicol announced that any member of the public wishing to audio or video record a Council Meeting must give notice to the Borough Clerk prior to the meeting being recorded.

Mayor Nicol then opened the Work Session in compliance with the Open Public Meetings Act and recognized the Administrator who reported on the Borough's "Best Practice Report". The Borough had scored points. A minimum of thirty points were required to ensure that there would be no loss of state aid.

The report had been copied to Mayor & Council and he asked if any member of the Governing Body had any questions?

Now Therefore, be it Proclaimed, that October 2019 as Pregnancy and Infant Loss Awareness Month in the Borough and urge all employees and residents to join The TEARS Foundation in observing this event.

Turning to Recreation, Councilman Nolan advised that Biddy Basketball Sign-ups would begin on November 4th. Registration is on-line at the recreation Website. Councilman Nolan also reminded those assembled that the Boy Scout Annual Spaghetti & Meatball Dinner would be held at the Fire House on Saturday, October 19th. Mr. Garruzzo would be cooking and Councilman Garruzzo would be in attendance as well.

Councilman Garruzzo advised that following the August on-site assessment, the Law Enforcement Accreditation Commission of the New Jersey Association of Chiefs of Police convened on October 10th to review the Final Assessment for the Brielle Police Department. The accreditation process enables a Police Department to improve overall performance by the adoption of standards that contain a clear statement of professional objectives. The Brielle Police have conducted a self-analysis to determine how existing operations can be adapted to meet these objectives. A team of trained assessors verifies that the applicable standards have been implemented. Accreditation status is a significant professional achievement. Councilman Garruzzo added that the accreditation was valid for three years.

Chief Olsen is proud to report that the Brielle Police Department has met or exceeded all applicable accreditation standards. Chief Olsen wishes to acknowledge the work and dedication of his officers and in particular Lieutenant Michael Mechler, the Accreditation manager whose unwavering support and commitment saw the process through.

Councilman Garruzzo also offered praise for the Recreation Fall Festival and thanked all the participants. He also cited the Chili & Chowder event and noted the Mayor's active participation in the sampling.

Councilmen Gorham and Visceglia having no reports, the meeting was opened to the public.

There being no further comments, the meeting was closed on a motion by Councilman Nolan seconded by Councilman Gianforte at 7:39pm.

Resolution to urge voters to support the referendum on the election ballot in November, so that veterans or widowed spouses of veterans who reside in continuing care retirement communities (CCRC) will be eligible for property tax deduction

WHEREAS, the State Constitution for New Jersey authorizes veterans and widowed spouses of veterans who served in active duty during war and other times of emergency to receive a property tax deduction, in the amount of \$250 per year, in well-deserved recognition of their service to our country; and

WHEREAS, veterans and widowed spouses of veterans who reside in Continuing Care Retirement Communities (CCRC) have been unfairly denied eligibility for the \$250 property tax deduction because they do not own their units, even though they instead contribute to property taxes through a monthly payment, and even though they have made the same sacrifices as all veterans in our great country; and

WHEREAS, there are twenty-five CCRCs in the State which collectively house approximately 2,500 veterans or widowed spouses who are being denied the property tax deduction, including; and

WHEREAS, Senator Vin Gopal has sponsored legislation (S1331), that has been approved by the Senate and General Assembly, to extend the deduction to veterans and their widowed spouses in CCRCs;

WHEREAS, the extension of the deduction, because it requires an amendment to the State Constitution, must be approved by the voters at the ballot in November before it will become valid and effective; and

WHEREAS, the Mayor and Borough Council now desire to memorialize their support of the referendum on the ballot in November, and to urge the voters of this State to vote in favor of the property tax deduction for veterans and widowed spouses of veterans who reside in CCRCs;

NOW, THEREFORE, BE IT **RESOLVED** that the Mayor and Council of the Borough of Brielle urges voters to support the referendum on the ballot in November 2019, so that veterans and widowed spouses of veterans who reside in Continuing Care Retirement Communities ("CCRC") will be eligible for the \$250 property tax deduction.

BE IT FURTHER RESOLVED that the Borough Council believes that this small benefit to our veterans and widowed spouses of veterans who reside CCRCs is a proper and warranted acknowledgment of the tremendous sacrifices that veterans have given to
