There being no questions from Council or the Public, the work session was adjourned at 6:31pm on a motion by Councilman Gianforte seconded by Councilman Nolan.

MINUTES MARCH 23rd, 2020

ABSENT: COUNCILMAN VISCEGLIA

Following the announcement on recording devices, Mayor Nicol asked for a moment of silent prayer, a salute to the flag and a roll call.

Mayor Nicol then asked for a motion to approve the Minutes of the March 9th Regular Meeting. A motion was made by Councilman Garruzzo seconded by Councilman Gorham, all aye; no nays. Passed.

Councilman Garruzzo seconded by Councilman Nolan introduced Resolution 20-33 for Passage of the Consent Agenda.

Mayor Nicol then announced that the time had arrived for a hearing and further consideration of CALENDAR YEAR 2020 "AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMIT AND TO ESTABLISH A CAP BANK".

The hearing was opened on a motion by Councilman Gianforte seconded by Councilman Nolan.

The Administrator explained that the ordinance permitted the Borough to exceed the CAP if

needed and any surplus would be "banked" for use in future budget years.

The hearing was closed on a motion by Councilman Shaak seconded by Councilman Nolan.

Councilman Garruzzo seconded by Councilman Nolan introduced resolution 20-35 for passage on final reading. Vote: Councilmen Garruzzo, Gianforte, Gorham, Nolan & Shaak; all aye. No nays.

On a motion by Councilman Garruzzo seconded by Councilman Gianforte, Resolution 20-36 was

introduced to authorize publication of passage and adoption in the Coast Star according to law.

Vote: Garruzzo, Gianforte, Gorham, Nolan & Shaak; all aye. No nays. Passed.

The Mayor then called for committee reports and recognized Councilman Gianforte, Nolan,

Garruzzo & Gorham had no reports.

Councilman Shaak cited the passing of Public Works Superintendent Robert McArthur and

offered his sincere condolences to the family. He praised Mr. McArthur for his outstanding

contributions to the Borough over the years.

Councilman Shaak also noted that there were three cases of the coronavirus in Brielle. The Monmouth County Health Commissions had alerted County Dispatch so that any municipal

personnel, such as First Aid & Police, who were called to those locations would be advised of the

need to use precautions.

Councilman Gianforte found that admirable citing a recent case in Freehold where a victim of the

virus was in a traffic accident and three police officers were now under quarantine as they had

been unaware of the danger of exposure.

Councilman Shaak added that a Board of Health Guideline had been issued with detailed information on handling victims of the virus and that document had afforded a level of comfort to

the First Aid Squad.

The meeting was adjourned on a motion by Councilman Gianforte seconded by Councilman

Gorham at 6:40 pm.
