

MINUTES September 14th, 2020

PRESENT: MAYOR NICOL, COUNCILMEN GARRUZZO, GIANFORTE, GORHAM, NOLAN, SHAAK & VISCEGLIA, ATTORNEY MONTENEGRO & ADMINISTRATOR NOLAN.

ABSENT: NONE

Mayor Nicol convened the work session at 6:00pm, but as the Administrator had no report and there no comments from council or the public, the regular meeting began.

Mayor Nicol announced that this was a virtual meeting and is being recorded. The Mayor read the compliance statement and the Administrator having no report, but he asked permission to add a "house-keeping" resolution to the consent agenda to renew the Ship Wreck Grill liquor license. The Regular Council Meeting was opened in compliance with the Open Public Meetings Act. Mayor Nicol asked for a roll call.

Mayor Nicol then asked for a motion to approve the Minutes of the August 17th Regular Meeting. A motion was made by Councilman Gianforte seconded by Councilman Gorham, all aye, no nays. Passed.

A motion was made by Councilman Gianforte seconded by Councilman Shaak to state that all

Liquor License Resolutions were renewed with existing conditions: all aye. No Nays. Passed. (Note: The motion was made as a result of inquiries by resident Donald Ziliotto & Diane Lucianna 407 Ashley Avenue, respectively and Thomas Stuhmann, 106 Ocean Avenue, as to the retention of the existing conditions).

Vote: Councilmen Garruzzo, Gianforte, Gorham, Nolan, Shaak & Visceglia; all aye. No nays. Passed. (Councilman Garruzzo abstained of C, D, E, F, L & P).

Councilman Visceglia seconded by Councilman Gorham introduced Resolution 20-66 for Payment of Bills. Be It Resolved that the following bills be paid, and that the Mayor or President of Council be authorized to draw orders on the Chief Finance Officer for payment of the bills of September 14th, 2020 as reviewed by the Finance Committee and as listed on the Resolution and the Computer Bill List amended thereto. Vote: Council Members Garruzzo, Gianforte, Gorham, Nolan, Shaak & Visceglia: all aye. No nays. Passed

The Mayor announced that the time had arrived for a hearing and further consideration of “BOND ORDINANCE PROVIDING FOR THE ACQUISITION OF A FIRE TRUCK, APPROPRIATING \$650,000.00 THEREFORE AND AUTHORIZING THE ISSUANCE OF \$617,500.00 BONDS AND NOTES TO FINANCE A PORTION OF THE COSTS THEREOF, AUTHORIZED IN AND BY THE BOROUGH OF BRIELLE, IN THE COUNTY OF MONMOUTH, NEW JERSEY”.

The hearing was opened on a motion by Councilman Shaak seconded by Councilman Nolan.

The Administrator explained that the Fire Company needed a new truck and the ordinance provided the Borough with a variety of funding options.

The hearing was closed on a motion by Councilman Gianforte seconded by Councilman Gorham.

Councilman Garruzzo seconded by Councilman Nolan introduced Resolution 20-67 for passage on second and final reading of the foregoing Bond Ordinance in compliance with Local Bond Law. Vote: Councilmen Garruzzo, Gianforte, Gorham, Nolan, Shaak & Visceglia; all aye. No nays. None abstained. Passed.

Councilman Garruzzo seconded by Councilman Nolan, introduced Resolution 20-68 to authorize publication of passage and adoption of the Bond Ordinance in the Coast Star in accordance with the provisions of Local Bond Law. Vote: Councilmen Garruzzo, Gianforte, Gorham, Nolan, Shaak & Visceglia; all aye. No nays. Passed.

The Mayor then called for committee report. Councilman Gianforte having no report. Councilman Nolan advised that Flag Football would begin on September 19th and approximately 165 children had signed up for the program.

Councilman Nolan also noted that the Library had resumed normal hours of operation. Mayor

Nicol interjected that the Library was selling Fire Company shirts and they were not only attractive but supported a worthy cause.

Councilman Garruzzo gave the following report. Patrolman Thomas O'Horo Badge # 173 was born and raised in West Long Branch where he currently resides. Thomas was hired as a Class II Special Law Enforcement Officer for the Borough of Belmar in 2018 and successfully completed his Class II Special Law Enforcement Officer Training at the Monmouth County Police Academy. In 2019, Thomas took a position as a Class II Special Law Enforcement Officer in the Borough of Shrewsbury, where he also worked part-time as a police telecommunications operator and gained a great deal of experience supplementing patrols. Thomas is a graduate of Montclair State University where he received his bachelor's degree in Criminal Justice.

Patrolman Matthew Murphy Badge #174 was born and raised in Brick Township and presently resides in Toms River. Matthew was hired as a Class II Special Law Enforcement Officer for the Borough of Point Pleasant Beach in 2019 and successfully completed his Class II Special Law Enforcement Officer Training at the Ocean County Police Academy. In December of 2019, Matthew took a position as a full time Class II Special Law Enforcement Officer with the Pemberton Township Police Department where he, too, gained a great deal of experience performing patrol duties. Matthew is a graduate of Ocean County College where he earned his associate degree.

On September 8, 2020, the Police Department once again investigated a Motor Vehicle Theft, an attempted theft of a motor vehicle and several car burglaries. We continue to urge our residents to remove key fobs and lock all vehicles. On Saturday, September 12th, 2020, at 2:41 PM, Brielle Patrolman Allison McCabe observed a vehicle traveling at a high rate of speed on State Hwy. 35. northbound. Subsequent to a motor vehicle stop and a well-executed investigation, Patrolman McCabe, assisted by Patrolman Barilari, K-9 Nero and Patrolman Aridas, approximately 23.396 ounces of suspected heroin was seized. The individual apprehended was lodged in the Monmouth County Correctional Institution pending a bail hearing.

Councilman Shaak reminded the public that Clean-up week would take place the week of September 21st on the residents regularly scheduled day of collection.

The meeting was then opened to the public and there being no public comment the public portion was closed on a motion by Councilman Garruzzo, seconded by Councilman Nolan. The meeting was adjourned at 6:20 pm on a motion by Councilman Shaak, seconded by Councilman Gianforte.

4. A singer shall be permitted to entertain on the deck on Friday and Saturday evenings from 9:00 p.m. until 12:00 a.m. (Midnight) and on Sunday from 3:00 p.m. until 10:00 p.m. provided that such activity is in compliance with the provisions of Borough Ordinances.
5. No doors or windows can remain open while any live entertainment or background music is utilized on the deck.
6. On the Sunday prior to Memorial Day & on the Sunday prior to Labor Day, the deck may remain open until 1:00 a.m. The deck may also remain open until 1:00 a.m. on July 3rd. These exceptions are granted subject to the provisions of this resolution.

Borough of Brielle Model Civil Rights Resolution

A RESOLUTION TO AFFIRM THE BOROUGH OF BRIELLE'S CIVIL RIGHTS POLICY WITH RESPECT TO ALL OFFICIALS, APPOINTEES, EMPLOYEES, PROSPECTIVE EMPLOYEES, VOLUNTERS, INDEPENDENT CONTRACTORS, AND MEMBERS OF THE PUBLIC THAT COME INTO CONTACT WITH MUNICIPAL EMPLOYEES, OFFICIALS AND VOLUNTEERS

WHEREAS, it is the policy of the Borough of Brielle to treat the public, employees, prospective employees, appointees, volunteers and contractors in a manner consistent with all applicable civil rights laws and regulations including, but not limited to the Federal Civil Rights Act of 1964 as subsequently amended, the New Jersey Law against Discrimination, the Americans with Disabilities Act and the Conscientious Employee Protection Act, and

WHEREAS, the governing body of the Borough of Brielle has determined that certain procedures need to be established to accomplish this policy

NOW, THEREFORE BE IT ADOPTED by the Mayor and Council that:

Section 1: No official, employee, appointee or volunteer of the Borough by whatever title known, or any entity that is in any way a part of the Borough shall engage, either directly or indirectly in any act including the failure to act that constitutes discrimination, harassment or a violation of any person's constitutional rights while such official, employee, appointee volunteer, or entity is engaged in or acting on behalf of the Borough's business or using the facilities or property of the Borough.

Section 2: The prohibitions and requirements of this resolution shall extend to any person or entity, including but not limited to any volunteer organization or inter-local organization, whether structured as a governmental entity or a private entity, that receives authorization or support in any way from the Borough to provide services that otherwise could be performed by the Borough.

Section 3: Discrimination, harassment and civil rights shall be defined for purposes of this resolution using the latest definitions contained in the applicable Federal and State laws concerning discrimination, harassment and civil rights.

Section 4: The Administrator shall establish written procedures for any person to report alleged discrimination, harassment and violations of civil rights prohibited by this resolution. Such procedures shall include alternate ways to report a complaint so that the person making the complaint need not communicate with the alleged violator in the event the alleged violator would be the normal contact for such complaints.

Section 5: No person shall retaliate against any person who reports any alleged discrimination, harassment or violation of civil rights, provided however, that any person who reports alleged violations in bad faith shall be subject to appropriate discipline.

Section 6: The Administrator shall establish written procedures that require all officials, employees, appointees and volunteers of the Borough as well as all other entities subject to this resolution to periodically complete training concerning their duties, responsibilities and rights pursuant to this resolution.

Section 7: The Administrator shall establish a system to monitor compliance and shall report at

least annually to the governing body the results of the monitoring.

Section 8: At least annually, the Administrator shall cause a summary of this resolution and the procedures established pursuant to this resolution to be communicated within the Borough. This communication shall include a statement from the governing body expressing its unequivocal commitment to enforce this resolution. This summary shall also be posted on the Borough's web site.

Section 9: This resolution shall take effect immediately.

Section 10: A copy of this resolution shall be published in the official newspaper of the Borough in order for the public to be made aware of this policy and the Borough's commitment to the implementation and enforcement of this policy.
