Mayor Nicol then opened the Work Session in compliance with the Open Public Meetings Act and recognized the Administrator who had no report, but he asked permission to delete one liquor license renewal and add two Chapter 159 resolutions.

There being no questions from Council or the public, the work session was adjourned at 7:35 p.m. on a motion by Councilman Shaak seconded by Councilman Nolan.

Following the announcement on recording devices, Mayor Nicol asked for a moment of silent prayer, a salute to the flag and a roll call.

Councilman Garruzzo seconded by Councilman Gorham introduced Resolution 19-54 for Payment of Bills. Be It Resolved, that the following bills be paid, and that the Mayor or President of Council be authorized to draw orders on the Chief Finance Officer for payment of the bills of June 10th, 2019, as reviewed by the Finance Committee and as listed on the Resolution and the Computer Bill List amended thereto. The Mayor announced that the time had arrived for the introduction and passage on first reading of 'BOND ORDINANCE PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS TO THE WATER UTILITY, APPROPRIATING \$5,210,500 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$5,210,500 BONDS AND NOTES TO FINANCE A PORTION OF THE COSTS THEREOF, AUTHORIZED IN AND FOR THE BOROUGH OF BRIELLE, IN THE COUNTY OF MONMOUTH, NEW JERSEY.

Councilman Nolan seconded by Councilman Shaak introduced Resolution 19-55 for passage on Page 46

introduction and first reading in compliance with Local Bond Law. Vote: Councilmen Garruzzo, Gorham, Nolan & Shaak; all aye, no nays. Passed.

Councilman Garruzzo seconded by Councilman Nolan introduced Resolution 19-56 to authorize publication in the Coast Star for a hearing to be held on June 24th, 2019, at 7:30pm, at Borough Hall, in accordance with Local Bond Law. Vote: Councilmen Garruzzo, Gorham, Nolan & Shaak; all aye. No nays. Passed.

The Mayor then called for committee reports and recognized Councilman Nolan who informed the public that the summer reading program commenced on June 1st at the Library. The Library would also host a Social Security Workshop on June 18th with sessions at 11:00am and 6:30pm. On June 25th, Hackensack/Meridian Health would conduct an event on Foot & Ankle Health.

Turning to recreation, Councilman Nolan said that sign-ups for the September 28th Coaster Derby were taking place at Borough Hall. In closing he praised everyone involved in making the Brielle Centennial a noteworthy event and he also cited the splendid turn-out at the 2nd Annual P.B.A. Food Truck Event.

Councilman Garruzzo advised that the Marine Unit has been deployed and will be patrolling the Manasquan River periodically during the summer months. Residents and visitors should be aware that alcohol, dogs and smoking are prohibited on Treasure Island/Nienstedt Island.

On May 22nd, SLEOII Officers Tyrone Davis and William Tartis graduated from the Academy. Both officers were at the top of the class in Marksmanship and Officer Tartis received the Academic Award and Outstanding Trainee Award.

On June 7th, Brielle Officers participated in the 36th Annual Law Enforcement Torch Run for New Jersey Special Olympics. Officers were proud to have residents and students from the Elementary School participate with them in this noteworthy event.

Councilman Garruzzo thanked everyone involved with the Centennial and he too praised the P.B.A. for their community-oriented Food Truck Event.

Councilman Shaak, echoed his colleagues praise for both events and noted that the Centennial was twenty months in planning; it showed. He also thanked the police and the DPW for their contributions to the event and the dazzling historical display held at Curtis House sponsored by the Union Landing Historical Society.

Councilman Gorham having no report the meeting was opened for public comment.

Virginia Loftin, 407 South Street was recognized, and she asked if anything was being done regarding her request for a bike rack at Brielle Beach?

Councilman Nolan advised that he had verbal authorization for an additional kayak rack, and he would inquire at NJDEP if a bike rack could be included, but he reminded Ms. Loftin that NJDEP approval was required.

Ms. Loftin also commented on the number of dog waste bags being left in public areas of the Borough and urged the placement of additional disposal containers at key locations such as Donnelly Beach and Morgan Parkway. She also urged the placement of a trash receptacle at Donnelly Beach.

Ms. Lofton also voiced a concern over the use of pesticides on public land and she asked what chemicals were being used at Brielle Park? She requested the MDDS sheet for whatever was being employed. She also noted that, when the Elementary School was treated, parents were advised. She believed that residents should be forewarned when the park was being treated. Councilman Garruzzo & Shaak offered to address her concerns.

Councilman Shaak seconded by Councilman Gorham introduced Resolution 19-57.

Whereas, the Open Public Meetings Act permits the exclusion of the Public from a meeting in certain circumstances; and

Whereas, the Borough Council of the Borough of Brielle is of the opinion that such circumstances currently exist. Now Therefore Be It Resolved, by the Borough Council of the Borough of Brielle, County of Monmouth, State of New Jersey, on June 10th, 2019, as follows:

1. The Public shall be excluded from discussion of and action upon the hereinafter specified subject matters.
2. The general nature of the subject matter to be discussed is as follows: "Pending Litigation".
3. It is anticipated at this time that the above stated subject matters will be made public when the need for confidentiality no longer exists.

Vote: Councilmen Gorham, Nolan & Shaak aye. No nays. Councilman Garruzzo recused himself. And left the room.

The Executive Session began at 7:47 pm and was adjourned on a motion by Councilman Shaak seconded by Councilman Gorham at 8:12pm. Attorney Montenegro advised that Council had been updated on the progress of current litigation and that the matter would be made public upon final resolution.

There being no public comment, the meeting was closed on a motion by Councilman Shaak seconded by Councilman Nolan at 8:13 pm.
